- Ministry of Corporate Affairs ("MCA") vide its Circular dated September 19, 2024 read together with its Circulars dated April 8, 2020, April 13, 2020, May 5, 2020, January 13, 2021, May 5, 2022, December 28, 2022 and September 25, 2023 (hereinafter collectively referred to as "MCA Circulars") and other applicable circular (s) / notification(s) issued by MCA, have permitted the companies to conduct their General Meetings through Video Conferencing ("VC") or Other Audio-Visual Means (OAVM), without the physical presence of the Members at a common venue.
- In accordance with the MCA Circulars and the provisions of the Companies Act, 2013 ("Act"), the 30th Extraordinary General Meeting ("EGM" of "the Meeting") of GMR Hyderabad International Airport Limited ("GHIAL" or "the Company") is scheduled to be held on Wednesday, April 9, 2025, at 4.00 p.m. (IST) through VC.
- 3. As per the provisions of the Act and the Rules thereunder, the Company is not required to provide the facility of e-voting.
- 4. The deemed venue for the EGM is the address of the Registered Office of the Company i.e. at GMR Aero Towers, Rajiv Gandhi International Airport, Shamshabad, Hyderabad 500 108, Telangana.
- 5. A Member entitled to attend and vote at the EGM is entitled to appoint a proxy to attend and vote at a poll instead of himself or herself and such proxy need not be a member of the Company. However, pursuant to MCA Circulars on holding of EGM through VC / OAVM, the requirement of physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxy by the Member will not be available for the EGM and hence the Proxy Form, and Attendance Slip are not annexed to this EGM Notice.
- 6. This Notice convening the 30th EGM is being sent only through electronic mode i.e. by email to all the Members and others entitled to their e-mail addresses registered with the Company. The Notice has been uploaded on the website of the Company at <u>www.hyderabad.aero</u>.
- 7. The explanatory statement pursuant to Section 102(1) of the Act in respect of Special Business is annexed hereto, as Annexure-1.
- 8. All the documents referred to in the 30th EGM Notice in respect of special business, which are to be kept open for inspection by the Members of the Company, will be available for inspection through electronic mode during 11.00 am and 5.00 pm on all working days till the date of the EGM. Members seeking to inspect such documents can send an email from their registered email id to ghial-cs@gmrgroup.in. Further, the Members seeking any information with regard to any matter to be placed at the EGM, are requested to write to ghial-cs@gmrgroup.in, on or before April 1, 2025 and response for the same will be sent by the Company accordingly.
- 9. The attendance of the Members attending the EGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Act.

Government / Government Entities intending to nominate their authorised representatives to participate in the Meeting are requested to forward to the Company, the Authorisation Letter. - 11. The instructions or details of the EGM i.e., access link to the VC or OAVM, login id, passwords, helpline numbers, e-mail id of a designated person who shall provide assistance for easy access to the EGM, shall be shared separately.
- 12. Facility for joining the EGM will be kept open for 15 minutes before the scheduled time of the EGM and shall not be closed till the expiry of 15 minutes after the scheduled time of the EGM.
- 13. The Chairman of the Board will preside as the Chairman of EGM. In case, the Chairman is not present, the Directors present will elect one among themselves to be the Chairman of the EGM. If no Director is willing to act as the Chairman or if no Director is present within 15 minutes after the time appointed for holding the EGM, the members present shall choose one of the members, to be the Chairman of EGM.

ANNEXURE-1 TO THE 30TH EGM NOTICE

Explanatory Statement pursuant to Section 102 (1) of the Companies Act, 2013 and applicable regulations of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Item No. 1

GMR Hyderabad International Airport Limited ('GHIAL' / 'the Company'), is a joint venture company (JV) promoted by GMR Group [i.e. GMR Airports Limited (formerly GMR Airports Infrastructure Limited] (holding 74% equity) in partnership with Airports Authority of India (holding 13% equity) and Government of Telangana (holding 13% equity).

As per Shareholders Agreement (GHIAL-SHA) dated September 30, 2003 entered into between Government of Telangana, Airports Authority of India (AAI), GHIAL and Sponsors:

- So long as AAI and GoT together hold not less than 26% shareholding, they will have the right to nominate two Directors each.
- the Sponsors will have the right to nominate all other Directors, excluding Lender's nominees (if any).

The Company received a communication from Airports Authority of India (AAI), a shareholder of the Company, vide its letter dated February 6, 2025, nominating Mr. S. Radhakrishnan, Executive Director (Finance)-I, AAI as one of its representative Directors on the Board of Directors of the Company, in place of Mr. Dharmendra Bhojwani, upon his superannuation from the services of AAI. Accordingly, Mr. Dharmendra Bhojwani (DIN: 08826067), ceased to be a Director of the Company with effect from February 6, 2025, being the date of receipt of the communication by the Company.

Pursuant to the provisions of Section 161 of the Companies Act, 2013, and based on the recommendation of the Nomination and Remuneration Committee, Mr. S. Radhakrishnan (DIN 10982461) was appointed by the Board of Directors, as an Additional Director of the Company, with effect from March 4, 2025 to hold the Office up to the date of the next Annual General Meeting of the Company or the last date on which the Annual General Meeting should have been held, whichever is earlier. Further, as per Regulation 17 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the appointment of a director is required to be approved by the shareholders at the next General Meeting of the Company or within a period of three months from the date of appointment, whichever is earlier.

The details of Mr. S. Radhakrishnan pursuant to Clause 1.2.5 of the Secretarial Standard-2 on General Meetings, are given in Annexure-2.
